Town of Nantucket
Public Comment Policy
Adopted by Select Board
February 12, 2025

A. Purpose:

This Policy is adopted to facilitate orderly and efficient public comment periods at meetings of Town public bodies. It will protect the ability of the residents of Nantucket, and other persons, to provide feedback or information to pertinent public bodies regarding matters of public interest, Town initiatives, operations, services, and programs. To allow speakers a fair opportunity to address a public body, and to ensure the public body may accomplish its stated business in an efficient manner, these guidelines seek to ensure compliance with the Open Meeting Law and meet other legal and constitutional obligations. Meetings of public bodies in the Town of Nantucket should be places to engage in orderly and peaceable discourse.

B. Authority:

Principles of free speech and freedom to petition the government, fundamental rights protected by the United States and Massachusetts Constitutions, prohibit public bodies from preventing all speech that may be upsetting or offensive. As such, this Policy establishes reasonable time, place, and manner restrictions sufficient to facilitate orderly and peaceable public comment periods at meetings of elected and appointed public bodies of the Town.

C. Legal Standards:

Meetings of public bodies are subject to the requirements of the Open Meeting Law, G.L. c. 30A, §§ 18-25. The Open Meeting Law empowers the chair of a public body to preside at and regulate the proceedings of meetings. Pursuant to G.L. c. 30A, § 20(g), no person shall address a meeting of a public body without permission of the chair, and all persons shall, at the request of the chair, be silent. Any person wishing to speak at an open meeting must first be recognized by the chair. All questions raised and all comments made by a duly-recognized speaker must be directed to the chair of the public body alone, not to individual members of the public body, staff, or the public. The chair is authorized to maintain order, and, although a rare occurrence, has authority, after appropriate

warnings are ignored, to take action up to and including removal of a person who is disrupting a meeting.

D. Application:

To secure the rights of the public to participate in public comment periods in the Town of Nantucket in a manner consistent with law, and, to thereby protect the Town and members of elected and appointed bodies from civil rights claims, this policy shall apply to all public bodies in the Town of Nantucket.

E. Procedures:

1. All agendas of multiple-member bodies in the Town of Nantucket shall include a period for Public Comment, subject to the limitations set forth in paragraph 3. Where to place Public Comment on the agenda is at the discretion of the chair. If public comment is invited during a separate agenda item, this Policy shall govern.
2. While statements made during a Public Comment period are not required to address an agenda item for that particular meeting, such comments must relate to a matter within the public body's jurisdiction. Public comments on matters outside the public body's jurisdiction may be ruled out of order by the chair. To avoid due process issues, a person seeking to provide comments on a matter appearing on the same agenda will be asked to defer until the specific agenda item is reached.
3. Each speaker will be allowed to speak once for up to 3 minutes. The chair will curtail verbal comments exceeding the allotted time.
4. A recognized speaker may not cede or assign their time to another unless such an assignment is required as reasonable accommodation for such person because of a disability. All speakers who may need an accommodation are strongly encouraged to contact Town staff or the chair of the public body at least 48 hours prior to the meeting. That said, to facilitate an efficient public comment period, groups that have multiple speakers with the same viewpoint may consider consolidating their comments or designating one person to speak on their individual behalf's.

F. Disruptive Conduct/Unprotected Speech:

Disruptive conduct and engaging in other unprotected speech, including but not limited to the following, may be grounds for the chair of a public body to curtail speech and take other action as appropriate:

1. Speaking without being recognized;
2. Continuing to speak after the chair has curtailed additional verbal comment;
3. Interrupting a recognized speaker;
4. Speaking about matters not within the jurisdiction of the public body;
5. Engaging in conversations while another person is speaking;

6. Making true threats of violence directed toward a particular individual; and
7. Making comments inciting imminent lawlessness.

G. Public Body Response:

1. A public comment period is a listening session, and the public body is there to listen. The public body, in fact, should not respond to matters raised at the meeting unless they are on the agenda for the same meeting.
2. Matters raised during public comment periods are not required to, and are unlikely to, be addressed or resolved by the public body at the same meeting. Such matters may be appropriately deferred to a noticed-agenda item at a future meeting due to Open Meeting Law considerations.
3. At the sole discretion of the chair of the public body, matters raised during public comment may or may not appear on a future agenda or be referred to the Town Administrator for appropriate action, if any.
4. A public body cannot demand that persons attending meetings or participating in public comment be civil to one another. Nevertheless, the Town, or the members of the public, and those that appear before them are encouraged to make any/or all residents of the Town feel welcome, including listening to them speak, and acknowledging that speakers may have a different viewpoints.

Disclaimer: A Public Comment period is not a time for debate or response to comments by the public body. Comments made during the Public Comment period do not reflect the views or the positions of the public body. Because of constitutional free speech principles, the public body does not have the authority to prevent all speech that may be upsetting and/or offensive during the public portion of the meeting.

H. Enforcement:

Concerns about Public Comment Periods may be brought to the attention of the Town Manager, who will discuss the concerns with the chair of the public body, and take appropriate action. Failure to comply with this Policy may be deemed a violation of the Town's Code of Conduct, and grounds for the removal of an appointed official.

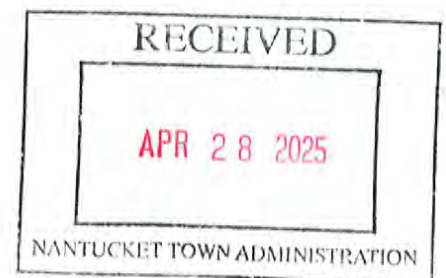

I am interested in the Board of Health because as a full-time resident of Nantucket I am passionate about the community and the health of this Island for its current population and future generations. Nantucket and its residents and visitors experience a unique climate and community that can put intense strain on the health and wellbeing of the people and the island itself. I believe that my experiences and skillset would bring a depth of knowledge that would complement the existing experience of members on the Board. My skillsets would help ensure efforts are in place to address the evolving needs of the population.

If appointed I would be dedicated to ensuring my presence at all meetings in person in accordance with the meeting schedule of the Board of Health.

My work experience as a Project Manager II at Fidelis Care makes me well suited to understanding the health needs of

Nantucket's population. During my time at Fidelis Care, my role was to identify health care gaps in populations across New York State and develop programs with Clinical Directors at the company to address these care gaps by increasing access to quality care based on their needs. As Project Manager I ensured our programs were maintained with integrity to achieve specific health care goals for our members.

In my current role as Project Manager at Nantucket Cottage Hospital, I have gained experience in analyzing our patient's health data to identify and solve ways to address care gaps across diverse subsets of our patient population that are unique to Nantucket. These experiences have reinforced my critical decision-making through adjusting clinical workflows by financial and operational impacts. Through partnership with clinicians, I have helped to implement these workflows with the goal of increasing access to care and quality of care.

If appointed to the Board of Health, I would strive to gain a deeper understanding of local public health issues and to address and solve problems commonly faced by our community. Through a position on the Board of Health, and as an active community member, my aim is to increase health status through public health efforts across the Island. I am confident that my critical evaluation skills and decision-making background can support this community and serve to facilitate rulings in meetings that support the common good.

If appointed to the Board of Health, I intend to secure a partnership with Nantucket Cottage Hospital to increase the volume of PFAS blood tests ordered and completed by our population. This partnership would provide us with the data necessary to ensure we continue to respond to our Island-wide crisis proactively. The expanding issue of PFAS contaminated water sources are a reality which is poised to pollute our island and its inhabitants for years to come. We need to address this issue to protect our population from an impending future of medical issues. In tandem with this effort, educating the community is essential to reach as many people as possible, and offering accessible testing is imperative to support the future of our Island. While the town and Board of Health have made great efforts and progress to test the water across the Island, minimal efforts have been made from a medical perspective on managing this issue. From my experience at Nantucket Cottage Hospital, it is not normal practice for PCPs to order a blood test for PFAS, yet they are covered by most insurances. By implementing both testing efforts and education efforts, we can ensure our population is prepared in the event they have high levels of PFAS in their blood. They can seek guidance from a medical professional and properly take the next steps in managing their care.

This statement is attached to and supplements the Committee Interest Form, Town of Nantucket.

I am qualified for COA by my life experience.

(1) I took my wife of 54 years through 18 years of Parkinson's Disease keeping her at home until the last breath with minimal home help. We lived alone throughout, the children grown and scattered in no position to help. I closed my legal practice to be her constant caregiver and experienced and witnessed both the depression and satisfaction that comes to a caregiver and patient alike.

(2) I experienced both the benefits and limitations of home health care, too often poorly paid with minimal training freely substituting without warning. The home health care available in Nantucket in 2019 was a remarkable cut above Bryn Mawr, PA. Through Alice Daniels and Nantucket Home Health Care, I was able to secure at home in Surfside four hours of caring support for my wife on Tuesday and again on Thursday, just enough to refresh my mind. They had my wife walking out on Weweeder. I have videos of her walking from the kitchen laughing with her aide close at hand in November 2019. Why did I ever leave the island to face COVID?

(3). During my wife's life time, we did not register as residents of Nantucket, although we split time evenly between Bryn Mawr PA and Surfside. I have now been here continuously ten months as a resident with no intention to leave. I returned to Nantucket in June 2024 with the intent of selling the Surfside house that had remained empty ...emotionally...since my wife passed four years before. I discovered I was happier here and could not, would not sell. I did the winter of 2024, loved it and recovered old friends.

(4) More important to this application, I discovered the wide support for the aged that marks Nantucket a special community beginning with Elder Services of Cape Cod and the Islands but greatly enhanced by the churches, the restaurants donating food and resources, the Rotary Club, Thanksgiving Day at the American Legion Post, so many individuals and families, endless names of volunteers who deliver services. I was not alone at Christmas, a family delivered dinner from the SeaGrille and stayed with me for an hour. I bought my fishing rod from Barry

Thurston in 1990; now he delivers a meal to me on Tuesday. Barry is older than I am; it is time I give back.

(5). I practiced law for 40 plus years in Philadelphia after three years as a Lt, USN on board a DE and as instructor at the NAS Pensacola during the Vietnam War. I served as Board President of the Clean Air Council in Philadelphia and ten years with the American Lung Association of Southeast Pa, NJ and Delaware, three years also as their Board President. I have three children and ten grands spread from Virginia, through PA and New Jersey. My late wife was a Nantucket Barnard who loved the island and spent many happy hours at Saltmarsh but she wanted at the end to be with over 90 of the Barnard name in the Quaker cemetery beside Longwood Gardens, PA. During her years here, I served without compensation two terms on the Non-Resident Tax Committee of Nantucket.

(6). With my life experience and some surface understanding of the needs of the aged and the many resources here, I would like to lend a hand to others so situated and hopefully learn more, and deliver more, to our diverse aged groups.

Such application shall also contain a statement as to the moral character of the applicant signed by at least five reputable citizens of the city or town of his residence, one of whom shall be an attorney-at-law. The appointing authority shall also investigate the reputation and character of every applicant and his fitness for said office. The chief of police or other official having charge of the police shall upon request give the appointing authority all possible assistance in making such investigation. The office of constable shall be filled only by appointment of an applicant hereunder who is found by the appointing authority, after investigation as aforesaid, to be a person of good repute and character and qualified to hold said office.

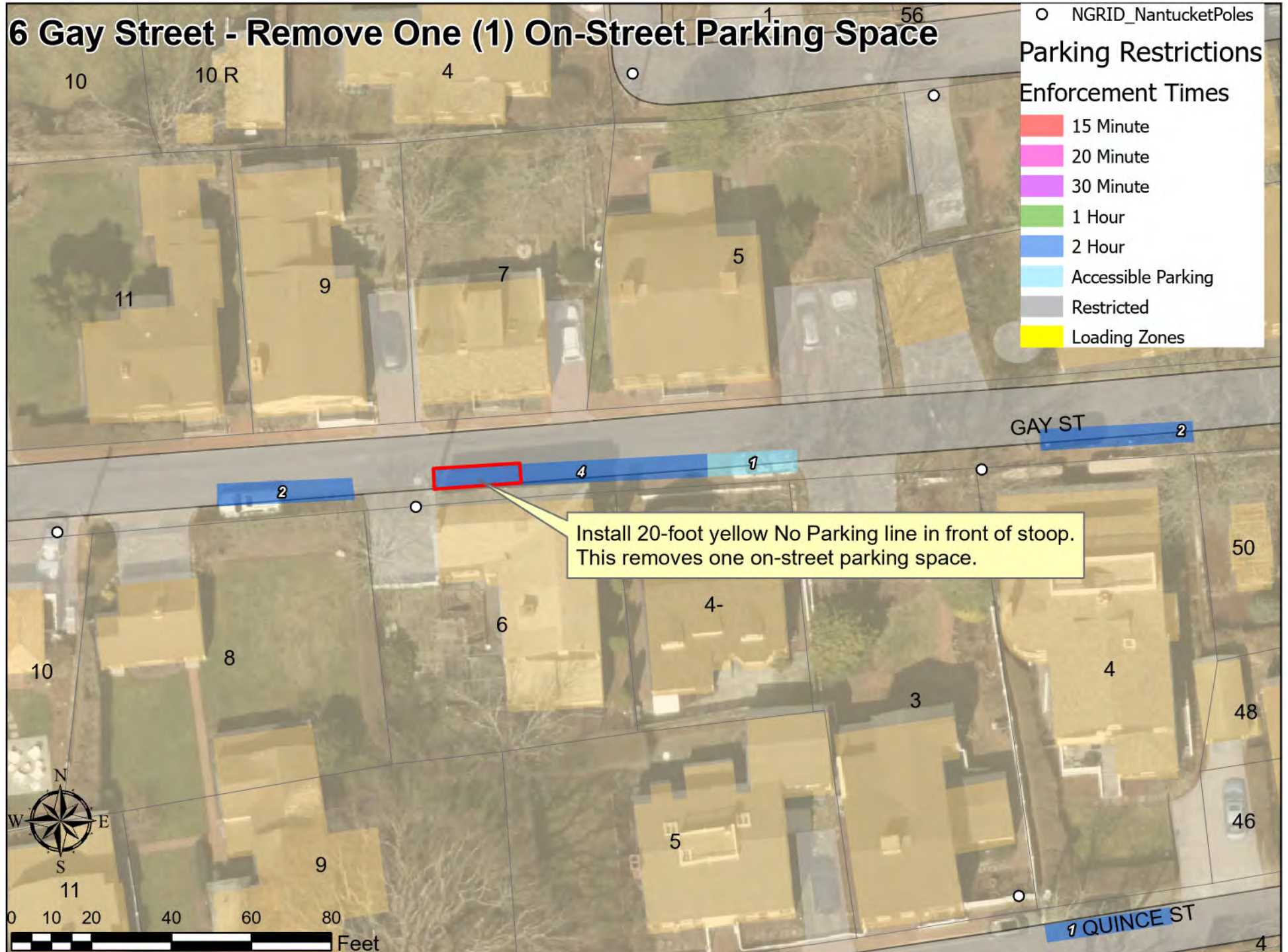

Traffic Safety has recommended the following that require Select Board approval:

1. 6 Gay Street – Add 20-foot yellow no parking line between utility pole and area along the front stoop. This would remove one on-street parking space.
2. 41 Liberty Street – Remove two (2) 2-hour parking spaces on Liberty St at India St. Removing space improves emergency response and two-way vehicle circulation.
3. 62 Centre Street – Designate two (2) on-street parking spaces to ADA spaces (one remaining parking space) and remove ADA space at the end of Church Ct.

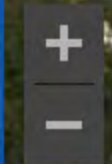
