	• There is a method that the commission can ensure the payment is made no matter what • Bond or deposit of money that is held Misurelli • Questioned the establishment of irrigation Madden • Could put sprinkles on overhead but it is drip irrigation above ground, not permanently Engelbourg • Thinks they should require a bond • Expensive project • Other manner might be to require a conservation restriction to be placed on the land • Explains why he thinks it's necessary • Questioned if a fence was installed without a permit and lightning Madden • Traced fence that was installed • Proposed to be removed • Lighting installed may not be in compliance so it will need to be addressed Briane • Ask for clarification on a conservation restriction Engelbourg • Explained a CR Misurelli • Plot is undevelopable as is so what would we gain by a CR Engelbourg • Explained that if the conditions changed, it would require the property to remain conservation Plandowski • Questioned the fines Engelbourg • Waiting for town council to figure out details on fines Plandowski • Is not in favor of fines Engelbourg • By requiring an NOI to be submitted as a result of an enforcement, the fee is 10x the regular filing fee which goes to the ConCom Turcotte • Adds that he thinks it's a great idea to put a CR on the property and explains why Engelbourg • Would require external party and approval of town and state Schafer • Kind of on the fence with a bond Engelbourg • Within discretion to revisit bond or fines issue Dell 'Erba • Had a long meeting with town council but wants to wait for an actual letter Engelbourg • Agrees Turcotte • If folks aren't ok with bond, NOI would require a COC

	Engelbourg • Explains yes Glenn Wood – represents homeowner • Recalls it difficult for a bond to be issued • Point has been raised that the bulk of work would be done immediately so if there was a failure, it would be dealt with • Have been working with the neighbors on the incursions • Concerns it's not appropriate to discuss the fines but did work hard to get the filing done and wants fines to be terminated as of last Friday Engelbourg • I appreciate it • Will take public comment from abutters then general public comment
Public Comment	Dan Bailey – Represents Delaine/Wagner family • Mr. Wood is correct but notes that the plan is not showing the plans for the Wagner property • Likes the CR • Most of the other properties surrounding have a CR • Explains benefit of CR • Vegetation removed cannot be restored • Explains again how this work occurred • Explains a letter submitted to the commission by independent reviewer • Explains points in letter • Doesn't think the restoration plan is detailed enough • Must be careful about invasives • Suggests 3-5 year regular monitoring • Commission can authorize planting plan and issue NOI after Engelbourg • That's what they want to do and agree that this planting plan is first step • Some details on plan need work • NOI allows alteration of this plan Dell 'Erba • Cautions against instant gratification is not best and is best to give plants space to grow into Engelbourg • Hears what representative is saying about a bond, another route could be to require contracts Misurelli • Believes if the property was sold, the bond would give more security Mr. Bailey • Confident the work will get done and agrees for the commission to use all tools at their disposal • Open OOC, and wants commission to revoke it due to the violation Engelbourg • Agrees that is an option and discusses other options Tony Cahill • Appreciates the ConCom and work • Thinks 16 and 10D never had site easements and additional planting should be done along property lines • Questioned fertilizers Madden • Anything done will be in compliance of regulations Engelbourg

	• Commission has the ability to restrict chemicals Henry Reider – Wauwinet neighborhood • Questioned size of trees and monitoring Engelbourg • Not as large as could be but they exist • Real questions are, is it feasible Allison Hudson – Wauwinet neighborhood • Questioned height of deer fence • Questioned the water usage as all neighbors are on wells • Echoed bond Wood • Suggestion to remove pool carries no weight • Trusts commission to flush this idea out of heads Misurelli • Suggests 3 ½ in caliper for trees Engelbourg • Wouldn't want to disturb wetland more • Thinks species are good • Not my favorite plan • Start with plan and go through NOI Misurelli • Can plant trees in such a way it restores Plandowski • Comments on deer fence Engelbourg • Closest thing it looks like Dell 'Erba • Happy to include research articles in the next packet for the bell curve you get out of plant material • Larger in the beginning leads to less growth • Transplant shock Engelbourg • Scientifically a good way to proceed • Requests from abutters to allow their scientists to allow the neighbors representative scientists to be present Wood • Can't agree to it now but will discuss it with homeowners Engelbourg • Site visit on April 1st Commissioners are available Madden is available Engelbourg • Are they holding off on accepting planting plan or approving Turcotte • Wants to see stuff to get in the ground but would like to hear other commissioners Engelbourg • Makes sense to wait if they are doing field viewing Schafer • Can they do both Engelbourg • Yes
